#### ***Two Honored with Medal of Valor for Extraordinary Courage***

Sacramento – The Department of Corrections and Rehabilitation today awarded Medals of Valor during its 25th Anniversary ceremony to two employees who exhibited extraordinary bravery and conduct in two incidents where public safety was at risk. Both received the Department's highest award for heroism and courage beyond the normal demands of correctional service.

**Correctional Officer Christopher A. Briones**, Ironwood State Prison, and Office of Correctional Safety **Special Agent Daniel A. Evanilla** are the CDCR Medal of Valor recipients for actions taken in 2008. The awards were presented by CDCR Secretary Matthew L. Cate at a ceremony conducted at the Hyatt Regency Hotel in Sacramento, during a prestigious event sponsored by the California Correctional Supervisor's Organization. More than 50 employees received awards that ranged from the Medal of Valor to Unit Citations.

The Medal of Valor is earned by employees distinguishing themselves by conspicuous bravery or heroism above and beyond the normal demands of correctional service. The employee shall display great courage in the face of immediate life-threatening peril and with full knowledge of the risk involved. The act should show professional judgment and not jeopardize operations or the lives of others.

Correctional Officer Chris A. Briones was honored for his fearlessness in facing adversity and responding to the aid of fellow officers being assaulted by inmates on Oct. 24, 2008, on a dining hall at Ironwood State Prison. Officer Briones, facing an immediate life-threatening situation, displayed exceptional courage by putting his own safety aside and entering the hall to save the one officer, and assist others, who were in danger of serious injury or death.

Office of Correctional Safety Special Agent Daniel A. Evanilla, who is assigned to the Special Service Unit based out of Rancho Cucamonga, is honored for his selfless role during a multi-agency search warrant service in June 2008. Special Agent Evanilla, facing immediate life-threatening peril, displayed exceptional courage by putting his own safety aside and crawled to a fellow law enforcement officer who had been shot and injured, and pulled that officer from the line of fire. Also honored at today's ceremony were Correctional Officer Tim Jackson, High Desert State Prison as the CDCR Correctional Officer of the Year, and Correctional Lieutenant Linda S. McManus, Avenal State Prison, as the CDCR Correctional Supervisor of the Year.
