CORRECTIONS TO PAY LETTER 06-35

GENERAL SALARY INCREASES

R03, S03, and M03 (Effective 07/01/06)

R03, S03, and M03 employees at Department of Corrections and Rehabilitation, Division of Juvenile Justice, Agency Code 110, are not eligible to receive the 3.5% general salary increase.

DOCUMENTATION: Departments should void the 07/01/06 effective date GEN transaction when processing the 04/01/06 effective date 335 transactions per Pay Letters 06-14A and 06-36 for R03 employees. The State Controller's Office will void the GEN transaction for S03 and M03 employees.

- S03 and M03 employees within the Department Corrections and Rehabilitation, at the Division of Juvenile Justice, Agency Code 110, are not eligible for the bonus. The exceptions area of the pay differential is updated to reflect this change.
- The definition of “on payroll” is updated for clarification purposes.

DOCUMENTATION: The State Controller's Office will issue the bonus pay for the eligible R03 employees and for employees meeting the updated “on payroll” definition. Departments should submit a Form STD. 674AR to establish an accounts receivable for the S03 and M03 employees at the Department of Corrections and Rehabilitation, Division of Juvenile Justice who received the bonus pay.

SPECIAL SALARY ADJUSTMENT:

The Department of Personnel Administration has approved salary increases for the following classes as shown below. In addition, Alternate Range Criteria 445 is added to the classes. (See below for effective dates.)

EMPLOYEE MOVEMENT:

Effective April 1, 2006, employees in positions within the Department of Corrections and Rehabilitation, Adult Operations and Adult Programs, will move to Range A and retain their salary rate and salary anniversary date.

Effective April 1 2006, employees within the Department of Corrections and Rehabilitation, Division of Juvenile Justice, will move to Range B and receive an 18.64 percent salary increase including employees who separated from State service prior to April 1, 2006 and have lump sum payments that extend beyond April 1, 2006. The lump sum payments shall be adjusted to reflect the salary increase. The increase shall be calculated by multiplying the employee's salary rate by 18.64 percent and rounding to the nearest dollar. Employees shall retain their salary anniversary date.

Effective July 1, 2006, only Range A will receive a 3.5 percent general salary increase. Employees in Range A shall be entitled to the 3.5 percent general salary increase including employees who separated from State service prior to July 1, 2006 and have lump sum payments that extend beyond July 1, 2006. The lump sum payments shall be adjusted to reflect the general salary increase.
